**POSITION:** Teacher Specialist, Speech and Language

**DUTIES:** Under the supervision of the Speech Language Department Supervisor, the incumbent in this position will provide speech, language, and aural habilitation assessment and intervention services to assigned students based on IEP referral. This includes test administration, clinical analyses, technical assistance, and staff development to appropriately serve students with diverse needs. The incumbent will act as resource and mentor to colleagues and staff, consult with prospective families, visiting colleagues and community members, write assessment reports, complete IEP paperwork, progress reports.

**WHO MAY APPLY:** 1) Possession of a Master's Degree in Speech/Language Pathology; 2) Possession of, or eligibility for, either a) California Speech-Language Pathology, Audiology and Hearing Aid Dispensers Board license, b) Clinical Rehabilitative Services Credential or Speech-Language Pathology Credential, or c) Communication Handicapped Credential; 3) Possession of, or eligibility for the American Speech-Language-Hearing Association Certificate of Clinical Competence is preferred; 4) Good writing skills; 5) Strong cultural perspective of Deaf; 6) Proficiency in ASL is preferred.

Applications will be screened and the most highly qualified applicants will be asked to interview.
